I agree not to sue or otherwise assert a claim of any nature whatsoever against Odyssey Gear Rental LLC, its agents and employees, arising out of or in any way related to my use of the Equipment.

I agree to indemnify, hold harmless, and defend Odyssey Gear Rental, LLC from and against any and all claims, costs, expenses, or liability (including attorney's fees), attributable to bodily injury, sickness, disease, or death, or to damage or destruction of property (including loss of use of property) caused by, arising out of, resulting from, or occurring in connection with any Activities I may engage in during use of the Equipment.

I understand and comprehend the risk associated with my participation in Activities while using the Equipment and I assume full responsibility for any risk of bodily injury, death or property damage arising out of use of the Equipment.

I have examined the Equipment, and I certify that I am familiar with the Equipment and that I am capable and skilled in the use of the Equipment.
